**AN RESOLUTION ADOPTING ORDINANCE NO. _____
ENTITLED “AN ORDINANCE TO AMEND ORDINANCE 787”**

WHEREAS, the Township Board of Plainfield Charter Township has determined that it is in the best interest of the public to develop and redevelop its commercial corridors to promote economic growth, mixed uses, well-designed and responsible development, attractive streetscapes and landscapes, and new opportunities for pedestrian and vehicular access, consistent with the Township’s Master Plan and other developmental objectives.

WHEREAS, on December 18, 2006, the Township Board adopted Resolution No. 06-55 / Ordinance No. 787 establishing the Plainfield Avenue Corridor Improvement Authority and designating the boundaries of the development area pursuant to Act 280 of 2005 now recodified as Part 6 of Act 57 of 2018 (“Act 57”).

WHEREAS, the Township Board may alter or amend the boundaries of the Plainfield Avenue Corridor Improvement Authority development area to include additional lands in the development area.

WHEREAS, the Township Board desires to, *inter alia*, amend the development area of the Plainfield Avenue Corridor Improvement Authority by including additional lands in the development area.

WHEREAS, Township staff and the Township’s consultant, have determined that the proposed amended development area contains transit-oriented development and a transit-oriented facility and meets the criteria for a qualified development area.

WHEREAS, Township staff and the Township’s consultant have determined that the proposed amended development area complies with the criteria set forth in Section 605(a) – (f) of Act 57.

WHEREAS, The Township Board finds that the proposed amended development area contains transit-oriented development and a transit-oriented facility and meets the criteria for a qualified development area under Act 57.

WHEREAS, The Township Board finds that the proposed amended development area complies with the criteria set forth in Section 605(a) – (f) of Act 57.

WHEREAS, Consistent with Section 605(g) of Act 57, the Township Board hereby agrees to expedite the local permitting and inspection process in the proposed development area and to modify the Township Master Plan to provide for walkable nonmotorized interconnections, including sidewalks and streetscapes throughout the proposed development area.

WHEREAS, The Township Board held a public hearing on May 11, 2026, during the regular meeting of the Township Board commencing at 6:00 p.m. (local time) regarding the adoption of a proposed ordinance and resolution amending the development area for the Plainfield Avenue Corridor Improvement Authority.

The Township Board of Plainfield Charter Township does hereby adopt the following Ordinance:

ORDINANCE NO. ____

AN ORDINANCE TO AMEND ORDINANCE 787

THE CHARTER TOWNSHIP OF PLAINFIELD ORDAINS:

Article 1. Amendment of Section 1 of Ordinance 787. Section 1 of Ordinance 787 of Plainfield Charter Township is hereby amended to read in its entirety as follows:

Section 1. Purpose and Intent. The Township Board (the “Board”) of the Township is strongly committed to the revitalization and redevelopment of commercial properties that have historically developed along that portion of Plainfield Avenue north of Four Mile Road and south of the Grand River within the Township (the “Plainfield Avenue Corridor”). The Board believes that revitalization and redevelopment of the Plainfield Avenue Corridor is necessary and vital to the continued economic vitality of the Township, may help preserve undeveloped areas within the Township and promote smart growth and conservation and utilization of natural and municipal resources.

Under the provisions of Act 280 of the Public Acts of 2005 recodified as the Recodified Tax Increment Financing Act, Act 57 of the Public Acts of 2018 (the “Act”), the Township may establish one or more corridor improvement authorities and utilize tax increment financing to encourage redevelopment of existing commercial corridors through analysis and short and long-term planning, and the construction, renovation, repair, remodeling, rehabilitation, restoration, preservation and reconstruction of buildings and public improvements, facilities and infrastructure.

The Board, having heard and considered testimony regarding the public need and potential benefits that are to be realized through the Act and having determined that it is necessary for the best interests of the public to redevelop and promote economic growth within the Plainfield Avenue Corridor, resolves to proceed with the creation and provide for the operation of a corridor improvement authority for the Plainfield Avenue Corridor pursuant to and in accordance with the provisions of the Act.

Article 2. Amendment of Section 4 Ordinance 787. Section 4 of Ordinance 787 of Plainfield Charter Township is hereby amended to read in its entirety as follows:

Section 4. Designation of Development Area. The Authority shall exercise its powers within the District, which is comprised of the area described in Exhibit A and depicted on the map in Exhibit B. The District shall be designated the “Plainfield Corridor Improvement District #1.” The boundaries of the District may be altered or amended by resolution of the Township Board pursuant to the Act.

Article 3. Amendment of Section 5 Ordinance 787. Section 5 of Ordinance 787 of Plainfield Charter Township, Michigan, is hereby amended to read in its entirety as follows:

Section 5. Authority Board. The Authority shall be under the supervision and control of a board consisting of the Plainfield Charter Township Supervisor or his or her assignee and not less than 5 or more than 9 appointed members as determined by the Township Board. Member eligibility and the composition of the board shall comply with requirements of the Act.

- (a) Terms. Each member of the Board shall serve for a term of four years except that of the members first appointed, an equal number of the members, as near as practicable, shall be appointed for 1 year, 2 years, 3 years and 4 years, respectively. A member shall hold office until the member's successor is appointed.
- (b) Vacancies. An appointment to fill a vacancy on the Board shall be made by the Township Supervisor for the un-expired portion of the term.
- (c) Compensation. Members shall serve without compensation, but may be reimbursed for actual and necessary expenses incurred in the performance of their duties.

- (d) Oath of Office. Before assuming the duties of office, each member shall qualify by taking and subscribing to the constitutional oath of office.
- (e) Chairperson. The Board shall elect a chairperson.
- (f) Treasurer. One of the Board Members may be elected Treasurer of the Authority, or the Board may employ and fix the compensation of a Treasurer. The Treasurer shall keep the financial records of the Authority and perform other duties delegated by the Board. The Treasurer shall furnish bond in an amount prescribed by the Board.
- (g) Secretary. One of the Board Members may be elected Secretary of the Authority or the Board may employ and fix the compensation of a Secretary. The Secretary shall maintain custody of the records, books, documents and other papers not required to be maintained by the Treasurer. The Secretary shall attend meetings of the Board, keep a record of its proceedings and perform other duties delegated by the Board.
- (h) Rules of Procedure. The board shall adopt rules governing its procedure and the holding of regular meetings, subject to the approval of the Township Board. Special meetings may be held if called in the manner provided in the rules of the board. Meetings of the Board shall be open to the public in accordance with the Michigan Open Meetings.
- (i) Public Records. The financial records of the Authority shall be open to the public in accordance with the Michigan Freedom of Information Act.
- (j) Director. The Board, in its discretion, may employ and fix the compensation of a Director, subject to the approval of the Township Board. The Director shall serve at the pleasure of the Board. The Director shall furnish bond in an amount prescribed by the Board. A member of the Board is not eligible to hold the position of Director.
- (k) Legal Counsel. The Board may retain legal counsel to advise the Board in the proper performance of its duties. The legal counsel may represent the Authority in actions brought by or against the Authority.

Article 4. Amendment of Section 9 Ordinance 787. Section 9 of Ordinance 787 of Plainfield Charter Township is hereby amended to read in its entirety as follows:

Section 9. Dissolution. Upon completion of its purposes for which it was organized, the Authority shall be dissolved by resolution of the Township Board. The property and assets of the Authority remaining after the satisfaction of the obligations of the Authority shall revert to the Township.

Article 5. Amendment of Exhibit A Ordinance 787. Exhibit A of Ordinance 787 of Plainfield Charter Township is hereby amended to read in its entirety as follows:

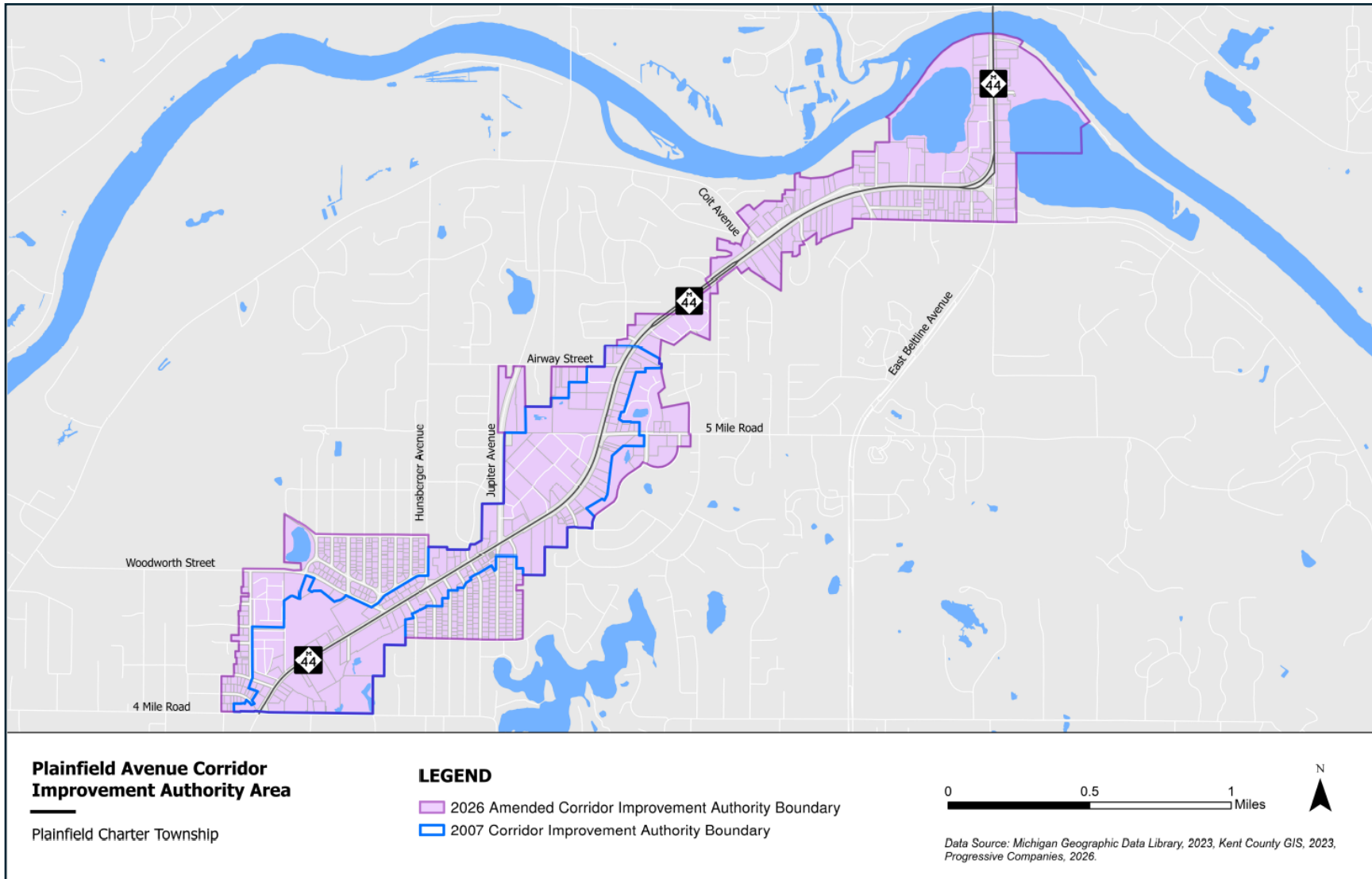
